This includes orders for enclosed capacitor banks, harmonic filters, voltage controllers, rectifiers and transformers. Nearly one third of the revenue from these orders is expected to be recognized in fiscal year 2022.

"The move towards a more sustainable world is driving our strong pipeline of new energy power systems orders," said Daniel P. McGahn, Chairman, President and CEO, AMSC. "Approximately half of these orders come from recent decarbonization efforts, which increase demand of metals, mining, and materials. Our Company has taken a central role in aiding decarbonization efforts by supplying products and capabilities that enable and drive low carbon emissions. We look forward to playing an important role in the future of sustainable and reliable energy with our solutions."

These products include transformers and rectifiers. Additionally, the systems help utilities manage their power quality concerns and expand grid capacity for renewable distributed generation.
