Ownership reflects 1-for-10 reverse split effected on March 24, 2015, and the transfer of 5,420 shares to the reporting person's ex-wife pursuant to a domestic relations order. The reporting person no longer reports as beneficially owned any securities owned by his ex-wife.
- Following all the transactions reported on this Form 4, the reporting person holds 815 shares indirectly through the company's 401(k) plan as of April 30, 2015. Ownership reflects 1-for-10 reverse split effected on March 24, 2015, and the transfer of 729 shares held through the company's 401(k) plan to the reporting person's ex-wife pursuant to a domestic relations order.
